WHEREAS, an emergency has arisen in Special Item of Appropriation in the amount of \$847,962.73 for the SUNUP Food Service Program, and no adequate provision has been made in the 2021 Temporary Budget for the aforesaid purpose, and N.J.S.A. 40A:4-20 provides for the creation of an emergency appropriation for the same; and

WHEREAS, by the award letter dated April 30, 2021, the New Jersey Department of Agriculture, Division of Food and Nutrition, Summer Food Program has awarded the City of Newark the SUNUP Food Service Grant in the amount of \$847,962.73. The aforementioned program will provide free, nutritious meals, and snacks to children who live in areas in which at least 50% of said population qualify for free or reduced-price meals under the National School Lunch Program within the City of Newark; and

WHEREAS, a previous resolution authorizing TE #33 and prior emergency resolutions submitted for Municipal Council approval totaled \$342,871,710.36; and

WHEREAS, N.J.S.A. 40A:4-20 provides that the Governing Body, by a two-thirds vote, may make temporary emergency appropriations for any purpose for which appropriations may lawfully be made for the period between the beginning of the current fiscal year and the date of the adoption of the budget for said year; and

WHEREAS, emergency appropriations adopted in 2021 pursuant to <u>N.J.S.A.</u> 40A:4-20, including this resolution, total \$......\$343,719,673.09.

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

- 1. The Governing Body by a two-thirds vote of its full membership hereby amends its temporary budget by making the following temporary emergency appropriation:
