**WHEREAS**, pursuant to N.J.S.A. 40A:9-120, the City of Newark may appoint up to fifty (50) Constables; and

**WHEREAS**, pursuant to N.J.S.A. 40A:9-121, the City of Newark may appoint a Constable for a term of three (3) years, unless the Municipal Council, by its resolution of appointment, fixes a one (1) year term; and

**WHEREAS**, the City of Newark wishes to appoint McGill T. Martin, to serve as a Constable for a term of three (3) years.

**NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:**

1. McGill T. Martin, 150 Hobson Street, Newark, New Jersey 07112, is hereby appointed as a Constable in accordance with his application to serve civil and criminal warrants, written summonses, complaints, repossessions and lockouts.
2. Prior to carrying out duties of his office and no later than thirty (30) days after the effective date of the appointment, the aforesaid appointee shall submit a Constable Bond, which shall be approved as to form, amount, and sufficiency of Surety by resolution of the Newark Municipal Council.
3. This appointment shall be for a period of three (3) years from the date of the appointment or the expiration of the Constable Bond, whichever occurs first.
