**WHEREAS**, the City of Newark wishes to enter into Cost Reimbursement Agreement No. 2012-DT-BLA-201, termed Federal Aid Agreement, with the New Jersey Department of Transportation, Division of Local Aid and Economic Development for the McClellan Street Underpass (Final Design); and

**WHEREAS**, the Cost Reimbursement Agreement No. 2012-DT-BLA-201, for the McClellan Street Underpass (Final Design), City of Newark, Essex County, STP-7608(104)PE, provides that all allowable costs incurred for the performance of work in the Scope of Work attached to the Cost Reimbursement Agreement, shall be eligible for reimbursement from the effective date of September 19, 2011. All such work shall be completed by September 19, 2016, in an amount not to exceed \$1,099,003.00; and

**WHEREAS**, the City of Newark appoints the Mayor and/or his designee, the Director of the Department of Engineering, to act as the authorized person to execute the Cost Reimbursement Agreement No. 2012-DT-BLA-201.

**NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:**

1. The Mayor and/or his designee, the Director of the Department of Engineering, are hereby authorized on behalf of the City of Newark to execute Cost Reimbursement Agreement No. 2012-DT-BLA-201 with the New Jersey Department of Transportation for the McClellan Street Underpass (Final Design), City of Newark, Essex County, STP-7608(104)PE, as per terms and conditions of the Cost Reimbursement Agreement..
2. The Mayor and/or his designee, the Director of the Department of Engineering, are hereby authorized on behalf of the City of Newark to solicit proposals/receive bids to accomplish the objectives outlined in the Cost Reimbursement Agreement No. 2012-DT-BLA-201 for the McClellan Street Underpass (Final Design), City of Newark, Essex County, STP-7608(104)PE.
3. No work shall commence prior to the insertion of sufficient funds in the budget.
4. The Director of Engineering shall file a fully-executed copy of the Cost Reimbursement Agreement No. 2012-DT-BLA-201 in the Office of the City Clerk.
5. No municipal funds are required for execution of the Cost Reimbursement Agreement.
