**WHEREAS**, pursuant to N.J.S.A. 40A:9-120, Anthony Garcia, of Newark, New Jersey 07104, was appointed as a Constable pursuant to Resolution 7R8-a(S), adopted at the November 23, 2021, Regular Municipal Council Meeting; and

**WHEREAS**, pursuant to N.J.S.A. 40A:9-125, Anthony Garcia, of Newark, New Jersey 07104, must give a bond, in such form and amount as prescribed by the Governing Body and approved as to form and sufficiency by the Corporation Counsel and Municipal Council; and

**WHEREAS**, pursuant to N.J.S.A. 40A:9-121, a Constable must qualify within thirty (30) days of the initial adoption of the resolution of appointment, and shall hold office for a term of three (3) years.

**NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:**

1. The term of the Constable appointment of Anthony Garcia, of Newark, New Jersey 07104, is for a term of three (3) years from the date of appointment or the expiration of the Constable Bond, whichever occurs first.
2. The Constable Bond, in the amount of \$5,000.00, issued to Anthony Garcia, of Newark, New Jersey 07104, is approved as to form, amount, and sufficiency.

### **STATEMENT**
