WHEREAS, an emergency has arisen in the Special Item of Appropriation in the amount of

\$325,000.00 for the Summer Youth Employment Pilot Program (SYEPP), no provision has been made in the 2019 Temporary Budget for the aforesaid purpose and N.J.S.A. 40A:4-20 provides for the creation of an emergency appropriation for the same; and

**WHEREAS**, by Notice of Award, dated February 28, 2019, from the New Jersey Department of Labor and Workforce Development, the City of Newark has been awarded \$325,000.00 for SYEPP; and

**WHEREAS**, N.J.S.A. 40A:4-20 provides that the Governing body, by two-thirds votes, may make temporary emergency appropriations for any purpose for which appropriations may lawfully be made for the period between the beginning of the current fiscal year and the date of the adoption of the budget for said year; and

**WHEREAS**, emergency appropriation adopted in 2019, pursuant to N.J.S.A. 40A:4-20, including this resolution total..... \$251,223,330.61.

**NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:**

1. A temporary emergency appropriation be and the same is hereby made for the following classification:
