**WHEREAS**, an emergency has arisen in the Special Item of Appropriation in the amount of \$196,653.00 for the Safe and Secure Communities Program and no adequate provision has been made in the 2012 Temporary Budget for the aforesaid purpose and N.J.S.A. 40A:4-20 provides for the creation of an emergency appropriation for the purpose abovementioned; and

**WHEREAS**, by Resolution # 7R11-a dated May 2, 2012, the City of Newark was awarded \$196,653.00 for the Safe and Secure Communities Program to supplement the salaries for eight community service police officers; and

**WHEREAS**, N.J.S.A. 40A:4-20 provides that the Governing Body by a two-thirds vote may make temporary emergency appropriations for any purpose for which appropriations may lawfully be made for the period between the beginning of the current fiscal year and the date of the adoption of the budget for said year; and

**WHEREAS**, the emergency appropriations adopted in 2012 pursuant to N.J.S.A. 40A:4-20 including this resolution total \$216,665,441.63.

**NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:**

1. An emergency appropriation is and the same is hereby made for the following classification:

2. Said emergency appropriation shall be provided for in the 2012 budget.
3. A copy of this resolution shall immediately be filed with the City Clerk by the Budget Director of the City of Newark.

**STATEMENT**

This Legislation establishes the Appropriation in the amount of \$196,653.00 for the Safe and Secure Communities Program funded by the New Jersey Department of Law and Public Safety, Division of Criminal Justice. (City-wide)
