WHEREAS, an emergency has arisen in the Special Item of Appropriation in the amount of \$8,325,315.00 for the HIV Emergency Relief Program and no adequate provision has been made in the 2021 Temporary Budget for the aforesaid purpose and N.J.S.A. 40A:4-20 provides for the creation of an emergency appropriation for the purpose above-mentioned; and

WHEREAS, by the Letter of Intent dated November 6, 2020, the U.S. Department of Health and Human Services/Health Resources and Services Administration (HRSA) awarded the City of Newark funds for the HIV Emergency Relief Program for \$8,325,315.00. The aforementioned program will provide funds for the provision of health care and supportive services to the residents of the City of Newark; and

WHEREAS, a previous resolution authorizing TE #11 and prior emergency appropriations submitted for Municipal Council approval totaled \$4,701,423.00; and

WHEREAS, N.J.S.A. 40A: 4-20 provides that the Governing Body, by a two-thirds vote, may make temporary emergency appropriations for any purpose for which appropriations may lawfully be made for the period between the beginning of the current fiscal year and the date of the adoption of the budget for said year; and

WHEREAS, emergency appropriation adopted in 2021, pursuant to <u>N.J.S.A.</u> 40A: 4-20 including this resolution total......\$13,026,738.00.

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

- **1.** The Governing Body by a two-thirds vote of its full membership hereby amends its temporary budget by making the following temporary emergency appropriation:
- **2.** A temporary emergency appropriation be and the same is hereby made for the following classification.

- **3.** Said emergency appropriation is ratified from March 1, 2021 to the date of adoption of this authorizing resolution.
