WHEREAS, Resolution 7R3-b, adopted on September 20, 2023, authorized the Acting Director of the Department of Engineering to accept the proposal submitted by H2M Architects and Engineers Inc., 119 Cherry Hill Road, Suite 110, Parsippany, New Jersey 07054, and execute Contract #2023-01R PS, for the Modernization of Elevators at Multiple Sites, in an amount not to exceed Two Hundred Sixty-Eight Thousand Fifty Dollars and Zero Cents (\$268,050.00) from the 2023 Budget/Department of Engineering/NW011-200-2001-A-71660-B2023; and

WHEREAS, the original funding source for Contract #2023-01R PS was certified from the 2023 Budget/Department of Engineering/NW011-200-2001-A-71660-B2023 in the amount of Two Hundred Sixty-Eight Thousand Fifty Dollars and Zero Cents (\$268,050.00), however, these funds have been transferred to the Capital Budget Project fund, NW045-23A-23A00-A-94710-B2023; and
