WHEREAS, an emergency has arisen in Special Item of Appropriation in the amount of \$175,700.00, bringing total program resources to \$3,061,297.00, for the continued provision of Homeless Healthcare (HRSA) Program and no adequate provision has been made in the 2018 Temporary Budget for the aforesaid purpose and N.J.S.A. 40A:4-20 provides for the creation of an emergency appropriation for the purpose above-mentioned; and

Operating Agency: Department of Health and Community Wellness

Two-Thirds vote of full membership required.

WHEREAS, by award letter dated August 15, 2017, from the U.S. Department of Health and Human Services/Health Resources and Services Administration, the City of Newark was awarded the Homeless Healthcare (HRSA) Grant in the amount of \$175,700.00, to provide medical care, social services, substance abuse and mental health counseling to the homeless population within the City of Newark; and

WHEREAS, N.J.S.A. 40A:4-20 provides that the Governing Body by a two-thirds vote may make temporary emergency appropriations for any purpose for which appropriations may lawfully be made for the period between the beginning of the current fiscal year and the date of the adoption of the budget for said year; and
