WHEREAS, an emergency has arisen in Special Item of Appropriation in the amount of Six Million Seven Hundred Thirty-Two Thousand Two Hundred Sixty-Seven Dollars and Zero Cents (\$6,732,267.00) for Community Resource Center - American Rescue Plan/Capital Projects Fund (ARC - ARP/CPF) and no adequate provision has been made in the 2024 Temporary Budget for the aforesaid purpose and N.J.S.A. 40:4-20 provides for the creation of an emergency appropriation for the purpose above-mentioned; and

Two-Thirds vote of full membership required.

WHEREAS, by Resolution # 7R7-a dated December 6, 2023, the City of Newark accepted the Community Resource Center - American Rescue Plan/Capital Projects Fund (ARC - ARP/CPF), in the amount of Six Million Seven Hundred Thirty-Two Thousand Two Hundred Sixty-Seven Dollars and Zero Cents (\$6,732,267.00) from the New Jersey Department of Community Affairs, Division of Housing and Community Resources; and

WHEREAS, N.J.S.A 40A:4-20 provides that the Governing Body, by a two-thirds vote, may make temporary emergency appropriations for any purpose for which appropriations may lawfully be made for the period between the beginning of the current fiscal year and the date of the adoption of the budget for said year; and

WHEREAS, the emergency appropriations adopted in 2024 pursuant to <u>N.J.S.A.</u> 40A:4-20, including this resolution, total is \$ 17,080,509.00.

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:
