WHEREAS, an emergency has arisen in Special Item of Appropriation in the amount of \$3,183,450.00 for HOME Investment Partnership Act and no adequate provision has been made in the 2024 Temporary Budget for the aforesaid purpose and N.J.S.A. 40:4-20 provides for the creation of an emergency appropriation for the purpose above-mentioned; and

WHEREAS, by resolution 7R1-j dated December 6, 2023, The City of Newark accepted the HOME Investment Partnership Program FY2023, in the amount of \$2,686,431.00 from the United States Department of Housing and Urban Development (HUD); and

WHEREAS, N.J.S.A 40A:4-20 provides that the Governing Body, by a two-thirds vote, may make temporary emergency appropriations for any purpose for which appropriations may lawfully be made for the period between the beginning of the current fiscal year and the date of the adoption of the budget for said year; and

WHEREAS, the emergency appropriation adopted in 2024 pursuant to <u>N.J.S.A.</u> 40A:4-20 including this resolution total is \$ 3,183,450.00.

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:
