**WHEREAS**, N.J.S.A. 40A:4-87 provides that the Director of Local Government Services may approve the insertion of any Special Item of Revenue in the budget of any local unit when such item shall have been made available by law and the amount thereof shall not have been determined at the time of the adoption of the budget, and may approve the insertion of an appropriation item of equal amount for the purpose of carrying out the purposes of the law making such item of revenue available for expenditure; and

**WHEREAS**, the New Jersey Department of Health, Division of Community Health Services has made available \$487,394.00 for the Influenza Vaccination Initiative 2021; and

**WHEREAS**, by award letter dated October 19, 2020, the City of Newark has been awarded funds from the New Jersey Department of Health, Division of Community Health Services in the amount of \$487,394.00 to provide and enhance adult influenza vaccination coverage to the residents of Newark.

**NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:**

1. In accordance with the provisions of N.J.S.A. 40A:4-87, the City of Newark, New Jersey, hereby requests the Director of Local Government Services to approve a budget insertion in the amount of \$487,394.00 and an appropriation of an equal amount for the Influenza Vaccination Initiative 2021 in the budget year 2020 as set forth in Schedule A, attached hereto and made a part hereof.

2. The aforesaid insertion is, in the opinion of the Governing Body, warranted and authorized by N.J.S.A. 40A:4-87 and is necessary for the orderly operation of the municipality.
3. A copy of this resolution shall be filed with the Director of the Division of Local Government Services by the City Clerk.

### **STATEMENT**

This resolution establishes the revenue and appropriation for the 2020 Municipal Budget in the amount of \$487,394.00 for the Influenza Vaccination Initiative 2021. The New Jersey Department of Health, Division of Community Health Services is providing these funds. The project period is October 1, 2020 through June 30, 2021. (City-Wide)
