**WHEREAS,** pursuant to N.J.S.A. 40A:9-120, Abdias Artiles, of Newark, New Jersey 07106, was appointed as a Constable, pursuant to Resolution 7R8-b, adopted at the January 10, 2024, Regular Municipal Council Meeting; and

**WHEREAS,** pursuant to <u>N.J.S.A.</u> 40A:9-125, Abdias Artiles, of Newark, New Jersey 07106, must give a bond, in such form and amount as prescribed by the Governing Body and approved as to form and sufficiency by the Corporation Counsel and Municipal Council; and

**WHEREAS,** pursuant to N.J.S.A. 40A:9-121, a Constable must qualify within thirty (30) days of the initial adoption of the Resolution of appointment, and shall hold office for a term of three (3) years.

## NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

- 1. The term of the Constable appointment of Abdias Artiles, of Newark, New Jersey 07106, is for a term of three (3) years from the date of appointment or the expiration of the Constable Bond, whichever occurs first.
- 2. The Constable Bond, in the amount of \$5,000.00, issued to Abdias Artiles, of Newark, New Jersey 07106, is approved as to form, amount, and sufficiency.
