Whereas, N.J.S.A. 40A:4-20 provides that the Governing Body by a two thirds vote may make temporary emergency appropriations for any purpose for which appropriations may lawfully be made for the period between the beginning of the current fiscal year and the date of adoption of the budget for said year; and

Whereas, emergency appropriation adopted in 2012 pursuant to N.J.S.A. 40A:4-20 including this resolution total...\$4,444,630.00
