1. The Municipal Council does hereby indicate its support of The Halsey Street Festival and Brownmill Anniversary Block Party to be held on Halsey Street between Central Avenue and New Street (Central Ward), on Saturday, July 22, 2023, from 12:00 P.M. until 8:00 P.M.

The Municipal Council is co-sponsoring this special event and waives the City of Newark's Special Event Permit Application Fees of Five Hundred Fifty Dollars and Zero Cents (\$550.00), however, it does not waive insurance coverage requirements due to be provided by event organizers or costs above service charges described in R.O. 5:10-1 et seq.
