WHEREAS, the Resolution 7R4-A, adopted April 18, 2012, authorizing the Director of the Department of Engineering to execute Contract No. 03-2011, City-wide Streetscape - Phase I: Mt. Prospect Avenue, Lower Broadway and Bloomfield Avenue, referenced the incorrect contract amount of \$4,855,951.04; and

WHEREAS, the bid proposal submitted by the lowest responsible bidder English Paving, Inc., 650 Route 46 West, Clifton, New Jersey 07013, for Contract No. 03-2011, City-wide Streetscape - Phase I: Mt. Prospect Avenue, Lower Broadway and Bloomfield Avenue was \$4,712,982.00; and

WHEREAS, the Department of Engineering needs to amend Resolution 7R4-A, adopted April 18, 2012, authorizing the execution of Contract No. 03-2011, City-wide Streetscape - Phase I: Mt. Prospect Avenue, Lower Broadway and Bloomfield Avenue for the correct amount of \$4,712,982.00.

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

1. Resolution 7R4-A, adopted on April 18, 2012, is hereby amended to reflect the correct contract amount of \$4,712,982.00.
2. The Mayor and/or his designee, the Director of the Department of Engineering, are hereby authorized on behalf of the City of Newark to execute a contract with the lowest responsible bidder, English Paving, Inc., 650 Route 46 West, Clifton, New Jersey 07013, (Contract No. 03-2011, City-wide Streetscape - Phase I: Mt. Prospect Avenue, Lower Broadway and Bloomfield Avenue), for the total bid amount of \$4,712,982.00.
3. Attached hereto is a revised certification of funds issued by the Chief Financial Officer, City of Newark, which states that there are available sufficient legally appropriated funds in the amount of \$4,712,982.00, for the purpose set forth hereinabove. Copies of the certification of funds issued shall be filed in the Office of the City Clerk by the Director of the Department of Engineering together with this resolution.
