**WHEREAS,** pursuant to N.J.S.A. 40A:9-120 et seq., the City of Newark is authorized to appoint fifty (50) Constables; and

WHEREAS, the Municipal Council wishes to amend Resolution 7R9-e adopted on May 2,

2012, as to the appointment term of April 19, 2012 through April 18, 2013 to May 29, 2012 through May 29, 2013.

# NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

- 1. Timothy Peters, 15-19 Peck Avenue, Newark, New Jersey 07107, be and is hereby appointed Constable for a one (1) year term commencing on May 29, 2012 through May 29, 2013, in accordance with his application to serve subpoenas and collect fines.
- 2. Prior to entering and upon the execution of his office and no later than thirty (30) days after the effective date of the appointment, the aforesaid appointee shall submit a Constable Bond, which shall be approved as to form, amount and sufficiency of Surety by Resolution of the Municipal Council.
- 3. The Municipal Council hereby ratifies its authorization of this resolution from May 29, 2012 through the date of adoption of this amending resolution.

### **STATEMENT**

This resolution amends and authorizes the appointment of Timothy Peters of 15-19 Peck Avenue, Newark, New Jersey 07107, as a Constable for the term of one (1) year, May 29, 2012 through May 29, 2013 in the City of Newark, New Jersey.
