AN ORDINANCE AMENDING SECTION 23:5-14e, PARKING BY PERMIT ONLY IN DESIGNATED RESIDENTIAL AREAS, OF TITLE 23, TRAFFIC AND PARKING, OF THE REVISED GENERAL ORDINANCES OF THE CITY OF NEWARK, NEW JERSEY, 2000, AS AMENDED AND SUPPLEMENTED, BY ADDING COLLEEN STREET TO THE EXISTING PERMIT PARKING AREAS DESIGNATED LIST.

**WHEREAS**, the residents of Colleen Street have requested and submitted a petition for Permit Parking on Colleen Street between Stuyvesant Avenue and Dead End, in the West Ward.

# NOW, THEREFORE, BE IT ORDAINED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

**Section 1.** That Section 23:5-14e, Parking by Permit Only in Designated Residential Areas, of Title 23, Traffic and Parking, of the Revised General Ordinances of the City of Newark, New Jersey, 2000, be amended and supplemented by adding thereto the following:

Colleen Street, both sides between Stuyvesant Avenue and Dead End (Hours: 24hrs. / Days: Monday-Sunday)

- Section 2. Regulatory signs shall be erected and maintained by the City of Newark.
- **Section 3.** Any ordinance or parts thereof inconsistent with this ordinance are hereby repealed.

**Section 4.** This ordinance shall take effect upon final passage and publication and in accordance with the laws of the State of New Jersey.

Section 5. This ordinance does not require approval by the Commissioner of Transportation.
