Whereas, pursuant to N.J.S.A. 40A:9-120 et seq., the City of Newark is authorized to appoint up to 50 Constables and to establish the term for such appointment for a three-year term, unless a one (1) year term is fixed by resolution; and

Whereas, Tyrone Johnson, Sr., seeks appointment as a Constable, and the Municipal Council is desirous of fixing the term of his appointment at three (3) years; and

Whereas, Tyrone Johnson, Sr., shall qualify within thirty (30) days of his appointment in accordance

with N.J.S.A. 40A:9-120, et seq.

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

- 1. Tyrone Johnson, Sr., 825 South 13<sup>th</sup> Street, Newark, New Jersey, be and he is hereby appointed Constable for a term of three (3) years, in accordance with N.J.S.A. 40A:9-121, in accordance with his application to serve warrants and subpoenas.
- 2. Prior to entering upon the execution of his office and no later than thirty (30) days after the approval of the resolution of appointment, the aforesaid appointee shall submit a Constable Bond, which shall be approved as to form, amount and sufficiency of Surety by Resolution of the Municipal Council.
- 3. The term of office shall be for no more than a three-year term, commencing and terminating on the dates set in the Constable Bond, but no earlier than the date of the appointing resolution.

## STATEMENT

This resolution authorizes Tyrone Johnson, Sr., to serve as a Constable in the City of Newark, New Jersey, for a period of three (3) years from the date of the Constable Bond to its expiration whichever occurs first.
