**WHEREAS,** by an award letter dated July 1, 2012 from the New Jersey Department of Labor and Workforce Development, the City was awarded \$133,000.00 for the Workforce Learning Act Grant 2012 to provide funds for program operations; and

**WHEREAS**, the New Jersey Department of Labor and Workforce Development has made available \$133,000.00 for the Workforce Learning Grant 2012 (Citywide).

# NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY:

- 1. That in accordance with the provisions of N.J.S.A 40A:4-87, the City of Newark hereby requests the Director of the Division of Local Government Services to approve a budget insertion in the amount of \$133,000.00 and an appropriation of an equal amount for the budget year 2012 as set forth in Schedule A, attached hereto and made a part hereof.
- 2. That the aforesaid insertion is, in the opinion of the governing body, warranted and authorized by N.J.S.A. 40A:4-87 and are necessary for the orderly operation of the municipality.
- 3. A copy of this resolution shall be filed with the Director of the Division of Local Government Services by the City Clerk of the City of Newark.
