### **NEWARK, NEW JERSEY, THAT:**

- 1. The Corporation Counsel is hereby authorized on behalf of the City of Newark to execute and accept the terms of the Settlement Agreement and Release attached hereto.
- 2. Upon receipt by the Corporation Counsel of all documents deemed necessary, the Director of Finance is hereby authorized and directed to issue a check in the amount of Fifty Thousand One Hundred Twenty-Six Dollars and Ten Cents (\$50,126.10), which payment will be made payable to "Remington & Vernick Engineers, Inc., and their attorney, Ellis Medoway" and which payment will be mailed to One Centennial Square, Haddonfield, NJ, 08033.
- 3. Annexed hereto is the Certification of Funds issued by the Director of Finance, City of Newark, which states that there are available sufficient legally appropriated funds from Fund NW045, Dept. 007, Project 07CS0, Acct. 94710, B.Y. B2007 in the amount of Fifty Thousand One hundred and Twenty-Six Dollars and Ten Cents (\$50,126.10), for the purpose set forth herein. A copy of the Comptroller's Certification shall be filed in the Office of the City Clerk along with this Resolution by the Corporation Counsel.
- 4. A fully executed copy of the Settlement Agreement shall be filed in the Office of the City Clerk by the Corporation Counsel.
- 5. This Resolution shall be effective upon adoption in accordance with applicable State Law.
