1. Santiago B. Velazquez, 241 Broome Street, Newark, New Jersey 07108, be and he is hereby

appointed Constable for a term of three (3) years in accordance with N.J.S.A. 40A:9-121, in accordance with his application to serve subpoenas, writs and warrants.

- 2. Prior to entering upon the execution of his office and no later than thirty (30) days after the adoption of this resolution, the aforesaid appointee shall submit a Constable Bond, which shall be approved as to form, amount and sufficiency of Surety by Resolution of the Municipal Council.
- 3. The term of appointment shall be for a period of three (3) years from the date of adoption of this resolution to the expiration date of the Constable Bond, whichever occurs first.

STATEMENT

This resolution authorizes Santiago B. Velazquez, 241 Broome Street, Newark, New Jersey 07108, to serve as a Constable in the City of Newark, New Jersey, for a period of three (3) years from the date of adoption or the date of expiration of the Constable Bond, whichever occurs first.
