**WHEREAS,** pursuant to <u>N.J.S.A.</u> 40A:4-19 the Municipal Council of the City of Newark, New Jersey; adopted Resolution 7R1-R dated February 6, 2013, to provide temporary funds for the period of January 1, 2013 through March 31, 2013, until the adoption of the Operating Budget of the City of Newark, New Jersey; and Resolution #W2 dated February 28, 2013 to be considered and adopted at its scheduled meeting on April 3, 2013 to provide funds for the period of April 1, 2013 through April 30, 2013 until the adoption of the Operating Budget of the City of Newark, New Jersey; and

**WHEREAS,** additional appropriations will be required for the Water Utility from May 1, 2013 through May 31, 2013, until the adoption of the budget; and

**WHEREAS,** N.J.S.A. 40A: 4-20 provides that the Governing Body by a two-thirds vote may make temporary emergency appropriations for any purpose for which appropriations may lawfully be made for the period between the beginning of the current fiscal year and the date of the adoption of the budget for said year; and

**WHEREAS,** the emergency appropriations adopted in 2013, pursuant to <u>N.J.S.A.</u> 40A: 4-20 including this resolution total......\$32,415,512.

# NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

1. The Governing Body by a two-thirds vote of its full membership hereby amends its temporary budget by making the following temporary emergency appropriations for the Water Utility:
