WHEREAS, on March 12, 2013, the City of Newark through its Purchasing Director advertised to solicit bids for contractor(s) to provide, **Athletic Apparel**, to the Department of Neighborhood and Recreational Services, as per the bid proposal attached hereto; and

WHEREAS, the Division of Central Purchasing distributed eight (8) bid proposal packages to the prospective vendors following the date of advertisement; and

WHEREAS, on March 28, 2013, three (3) bids were received in response to this advertisement; and

WHEREAS, the Purchasing Director recommends that a line item award be made to JLMP Sporting Goods Corp., Metuchen Center, Inc., and All American Sports Corporation d/b/a Riddell All American, the only responsible bidders; and

WHEREAS, pursuant to N.J.S.A.40A:11-24, the responsive bidders consented to hold prices until such time as an award is made; and

WHEREAS, pursuant to N.J.S.A.19:44A-20.5 et seq., solicitations through public bidding in accordance with N.J.S.A.40A:11-1, et seq., meets the requirements of the fair and open process.

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

- 1. The Mayor and/or his designee, the Purchasing Director, are hereby authorized to enter into a contract with JLMP Sporting Goods Corp., 110 Mt. Pleasant Avenue, Newark, New Jersey 07104, to receive line items as per the price schedule, Metuchen Center, Inc., 10-12 Embroidery Street, Sayreville, New Jersey 08872, to receive line items as per the price schedule, and All American Sports Corporation d/b/a Riddell All American, 669 Sugar Lane, Elyria, Ohio 44035, to receive line items as per the price schedule, to provide Athletic Apparel, to the City, whose bids were received on the advertised due date and determined to be the only responsible bidders, based on line item awards in accordance with the bid specifications. The term of the contract will be established for a two (2) year term, pursuant to N.J.S.A.40A:11-3 (b).
- 2. There shall be no amendment or change of this contract without the approval of the Municipal Council by resolution.
- 3. There shall be no advance payment on this contract in accordance with N.J.S.A. 40A:5-16. Funds for 2013 and subsequent years are contingent upon appropriations; pursuant to N.J.A.C. 5:30-5.5(d) (2).
- 4. This is an open-ended contract to be used as needed during the term of contract. Thus, for any and all expenditures against this contract, a certification of the availability of sufficient funds, as required by N.J.A.C. 5:30-5.5(b) (2), shall be executed before a contractual liability is incurred each time an order is placed, covering the amount of the order. This contract shall not exceed \$50,000.00 for two (2) years.

- 5. A duly executed copy of the contract shall be forthwith filed in the Office of the City Clerk by the Purchasing Director.
- 6. If required by State Law, the City Clerk shall provide the appropriate notice of the award of this contract, to the State Comptroller no later than 20 business days following such award, in accordance with N.J.S.A. 52:15C-10 and the Notice of the Office of the State Comptroller dated May 7, 2008.
