WHEREAS, the Division of Traffic and Signals, Department of Engineering, City of Newark, advertised for the receipt of bids in accordance with the Local Public Contracts Law, N.J.S.A. 40A:11-1, et seq., on January 24, 2013, for Contract #04-2013, Citywide Traffic Calming Program; and

WHEREAS, on February 20, 2013, two (2) bids were received for Contract #04-2013, Citywide Traffic Calming Program; and

WHEREAS, based on a review of the bids, the Director of the Department of Engineering desires to accept the bid proposal submitted by the lowest responsible bidder, Granada Construction Corp., 147 Thomas Street, Newark, New Jersey 07114 and execute Contract #04-2013, Citywide Traffic Calming Program, for the total bid amount of \$272,500.00.

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

- 1. The Mayor and/or his designee, the Director of the Department of Engineering, are hereby authorized on behalf of the City of Newark to accept the bid proposal submitted by the lowest responsible bidder, Granada Construction Corp., 147 Thomas Street, Newark, New Jersey 07114, and execute Contract #04-2013, Citywide Traffic Calming Program, for the total bid amount of \$272,500.00.
- 2. Attached hereto is a certification of funds issued by the Chief Financial Officer, City of Newark, which states that there are available sufficient, legally appropriated funds in the amount of \$272,500.00 for the purpose set forth hereinabove. Copies of the certification of funds issued shall be filed in the Office of the City Clerk by the Director of the Department of Engineering together with this resolution.
