Whereas, the City of Newark wishes to implement the three (3) year option.

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

- 1. Pedro Rafael De la Cruz, 60 4th Street, Newark, New Jersey 07107, be and is hereby appointed as a Constable, in accordance with his application to serve subpoenas.
- 2. Prior to entering upon the execution of his office and no later than thirty (30) days after effective date of the appointment, the aforesaid appointee shall submit a Constable Bond, which shall be approved as to form, amount and sufficiency of Surety by Resolution of the Newark Municipal Council.
- 3. This appointment shall be for a period of three (3) years from the date of appointment or the expiration of the Constable Bond, whichever occurs first.
