**AN ORDINANCE AMENDING SECTION 23:15-1, STOP INTERSECTIONS, OF TITLE 23, TRAFFIC AND PARKING, OF THE REVISED GENERAL ORDINANCES OF THE CITY OF NEWARK, NEW JERSEY, 2000, AS AMENDED AND SUPPLEMENTED, BY DESIGNATING CUSTER PLACE AND CUSTER AVENUE A STOP SIGN INTERSECTION.**

**WHEREAS**, the Division of Traffic and Signals desires to improve safety at the intersection of Custer Place and Custer Avenue by requiring drivers to stop on Custer Place before entering the path of vehicles traveling on Custer Avenue, in the South Ward.

**NOW, THEREFORE, BE IT ORDAINED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:**

**Section 1..** That Section 23:15-1, Stop Intersections, of Title 23, Traffic and Parking, of the Revised General Ordinances of the City of Newark, New Jersey, 2000, as amended and supplemented, be amended by adding thereto the following:

***Custer Place and Custer Avenue with stop on Custer Place***

**Section 2.** Any ordinances or parts thereof inconsistent with this ordinance are hereby repealed.

**Section 3.** This ordinance shall take effect upon final passage and publication and in

accordance with the laws of the State of New Jersey.

**Section 4.** This ordinance does not require approval by the Commissioner of Transportation.

**STATEMENT**

This ordinance establishes the intersection of Custer Place and Custer Avenue as a stop intersection with vehicles stopping on Custer Place, in the South Ward.
