Whereas, at the request of the Municipal Council, the Department of Engineering is submitting a resolution to remove the bus stop on Maple Avenue nearside at Goldsmith Avenue; and

WHEREAS, New Jersey Transit does not recommend the removal of the bus stop on Maple Avenue nearside at Goldsmith Avenue; and

WHEREAS, pursuant to N.J.S.A 39:4-197(3)(a), the following described location is deleted as a bus stop.

DELETED BUS STOP:

In the South Ward, along Maple Avenue, northbound on the easterly side thereof at:

Goldsmith Avenue - nearside

Beginning at the southerly curb line of Goldsmith Avenue and extending 105ft southerly therefrom.

WHEREAS, pursuant to Section 39:4-197(3)(a) of Title 39 of the Revised Statutes of New Jersey, a municipality may by ordinance, resolution or regulation designate or delete a bus stop.

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

- 1. In the South Ward, the following described bus stop location is hereby deleted:
 - Along Maple Avenue, northbound on the easterly side, at Goldsmith Avenue (nearside). Beginning at the southerly curb line of Goldsmith Avenue and extending 105ft southerly therefrom.
- 2. No Municipal funds need to be expended for this act.
- 3. No Amendment will be made to this resolution without the approval of the Municipal Council of the City of Newark.
- 4. Upon approval, the Engineering Department will forward a copy of this resolution to the City Clerk's Office to notify them of the Local Government's approval for the deletion of a bus stop as stated.
- 5. Upon approval, a certified copy of this resolution shall be forwarded to New Jersey Transit to notify them of the Local Government's approval for the deletion of a bus stop as stated.
- Pursuant to NJSA 39:4-8 (e) of Title 39 of the Revised Statutes of New Jersey, the proposed bus stop deletion does not require New Jersey Department of Transportation's approval.
