WHEREAS, on July 25, 2005, the Municipal Council of The City of Newark (the "City") finally adopted Bond Ordinance No. 6S&FA(S) (the "Bond Ordinance") appropriating the sum of \$29,500,000 to finance various projects (the "Projects") and authorizing the issuance of \$29,500,000 in bonds or notes of the City to finance

the Projects; and

WHEREAS, the Municipal Council of the City has determined to revise certain of the projects contained in the Bond Ordinance; and;

NOW, THEREFORE, BE IT ORDAINED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK (not less than two-thirds of all members thereof affirmatively concurring), AS FOLLOWS:

<u>Section 1</u>. The chart in Section 3 of the Bond Ordinance is hereby amended to read as follows:

Section 2. The capital budget or temporary capital budget, as applicable of the City is hereby amended to conform with the provisions of this Bond Ordinance to the extent of any inconsistency herewith. In the event of any such inconsistency and amendment, the resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget or amended temporary capital budget, as applicable and capital program as approved by the Director of the Division of Local Government Services is on file with the Office of the Clerk and is available there for public inspection.

<u>Section 3</u>. Except as amended hereby, all other provisions of the Bond Ordinance shall remain in full force and effect. To the extent that any previous ordinance or resolution is inconsistent herewith or contradictory hereto, said ordinance or resolution is hereby repealed or amended to the extent necessary to make it consistent herewith.

<u>Section 4</u>. This Ordinance shall take effect 20 days after the first publication thereof after final adoption, as provided by the Local Bond Law.
