**WHEREAS**, the Newark Police Foundation of New Jersey fully understands and agrees that it is not entitled to receive any direct benefit from the City of Newark in exchange for its gift and shall receive only the indirect benefit of furthering its mission of making the City and its Police Officers safer through its gift.

## NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

- 1. The Mayor and/or his designees the Business Administrator and the Newark Police Director are hereby authorized pursuant to N.J.S.A. 40A:5-29 to accept a gift of twenty (20) mounted helmets and twenty-four (24) motorcycle helmets valued at Seven Thousand Five Hundred and Thirty Nine Dollars and Ninety Seven Cents (\$7,539.97).
- 2. The Municipal Council ratifies the acceptance of the gift from April 17, 2013 to the date of the adoption of this resolution.
- 3. No municipal funds will be expended in the acceptance of this gift.
- 4. A fully-executed copy of the gift award letter shall be filed in the Office of the City Clerk by the Police Director.
- 5. The original of this resolution shall be filed in the Office of the City Clerk by the Newark Police Department.
