Cooperative Purchasing participants assume full responsibility for all purchase transactions issued through State contracts, including Purchase Orders, delivery compliance, and payments; and

**WHEREAS**, the City wishes to utilize the **Vehicles**, **Sport Utility (SUV)** State Contract, T-2007 with the following vendor commencing adoption of this resolution upon complete delivery, not to exceed October 29, 2014.

**WHEREAS**, the Purchasing Director recommends the utilization of this State Contract award on the grounds that it provides **Vehicles**, **Sport Utility (SUV)**, State Contract, T-2007 according to specifications required by the City of Newark; and

WHEREAS, the total cost for the purchase of Vehicles, Sport Utility (SUV), is expected not to exceed \$123,540.00; and

WHEREAS, usage of this contract provides Vehicles, Sport Utility (SUV), as required by the Water and Sewer Utilities.

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

- 1. Pursuant to N.J.S.A. 40A:11-1 *et seq.*, and N.J.A.C. 5:34-7.29, the Purchasing Director is authorized to utilize contract # A83013, Celebrity Ford d/b/a Beyer Ford,170 Ridgedale Avenue., Morristown, New Jersey 07936 to provide **VEHICLES, SPORT UTILITY (SUV)**, State Contract, T-2007 for the period commencing from the adoption of this resolution, until delivery, not to exceed October 29, 2014.
- 2. There shall be no amendment of this resolution without the approval of the Municipal Council.
- 3. There shall be no advance payment on this State Contract in accordance with N.J.S.A. 40A: 5-16.
- 4. Funds for the purchase of these vehicles are encumbered on Purchase Order #7626 NW037, Dept.750, Div. 7505, Acct. 94330, budget B2013 for \$123,540.00. This contract shall not exceed \$123,540.00.
