WHEREAS, this resolution is within the first thirty (30) days of the year 2014; and

WHEREAS, 26.25% of the total appropriation of the 2013 Sewer Utility Budget exclusive of any appropriations made for interest and debt redemption charges, capital improvement fund and public assistance is \$7,084,000.00.

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

- 1. The following temporary appropriation be made and a certified copy of this resolution be transmitted to the Chief Financial Officer for his/her records.
- 2. The Governing Body by two-thirds vote of its full membership hereby amends its temporary budget by making the following temporary appropriations:
