**WHEREAS**, an emergency has arisen in Special Item of Appropriation in the amount of \$1,575,460.00, for the Urban Areas Security Initiative Grant and no adequate provision has been made in the 2014 Temporary Budget for the aforesaid purpose and N.J.S.A. 40A: 4-20 provides for the creation of an emergency appropriation for the purpose above-mentioned; and

**WHEREAS**, by authorizing Resolution 7R1-i dated December 4, 2013, the City of Newark accepted funds for the Urban Areas Security Initiative Grant from the State of New Jersey Office of Homeland Security and Preparedness in the amount of \$1,575,460.00 to provide region's ability to build, maintain and sustain national preparedness capabilities related to training, maintenance, emergency notification system within the City of Newark (City-wide); and

**WHEREAS**, N.J.S.A. 40A: 4-20 provides that the Governing Body by a two-thirds vote may make temporary emergency appropriations for any purpose for which appropriations may lawfully be made for the period between the beginning of the current fiscal year and the date of the adoption of the budget for said year; and

**WHEREAS**, the emergency appropriations adopted in 2014, pursuant to N.J.S.A. 40A: 4-20 including this resolution total.....\$7,365,935.00.

**NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:**

1. A temporary emergency appropriation be and the same is hereby made for the following classification.

2. Said emergency appropriation shall be provided for in the 2014 budget.
3. A copy of this resolution shall be filed with the Director of Local Government Services by the City Clerk of the City of Newark.

**STATEMENT**

This legislation authorizes and establishes the appropriation for the Urban Areas Security Initiative Grant in the amount of \$1,575,460.00. The State of New Jersey Office of Homeland Security and Preparedness is awarding the funds. The project period is September 1, 2013 through August 31, 2015 (City-wide).
