**WHEREAS**, the City of Newark wishes to implement the three (3) year option.

**NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:**

1. Jon M. Lowe, 85 Muhammad Ali Avenue, Newark, New Jersey 07108, be and is hereby appointed as a Constable, in accordance with his application to serve subpoenas, summonses, complaints, restraining orders, citations (State and Federal)
2. Prior to entering upon the execution of his office and no later than thirty (30) days after effective date of the appointment, the aforesaid appointee shall submit a Constable Bond, which shall be approved as to form, amount and sufficiency of Surety by Resolution of the Newark Municipal Council.
3. This appointment shall be for a period of three (3) years from the date of appointment or the expiration of the Constable Bond, whichever occurs first.
