# NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

- The Mayor and/or his designees the Business Administrator and the Newark Police Director are hereby authorized pursuant to <u>N.J.S.A.</u> 40A:5-29 to accept a gift from the Newark Police Foundation of New Jersey, 744 Broad street, 26<sup>th</sup> Floor, Newark, New Jersey 07102, of thirty (30) Vid-Shield Body Worn Hi-Definition Police Digital Cameras valued at Seventeen Thousand Nine Hundred Seventy Dollars and Zero Cents (\$17,970.00).
- 2. The Municipal Council ratifies the acceptance of the gift from April 27, 2013 to the date of the adoption of this resolution.
- 3. No municipal funds will be expended in the acceptance of this gift.
- 4. A fully-executed copy of the gift award letter shall be filed in the Office of the City Clerk by the Police Director.
