**WHEREAS**, on September 7, 2005, the Municipal Council adopted Ordinance 6S & FG, approving the First Amendment to the Original Plan as recommended by a resolution of the Central Planning Board dated July 5, 2005 (collectively, the "First Amended Plan"); and

**WHEREAS**, on March 9, 2010, the Municipal Council adopted Resolution 7R3-A(S), directing

the Central Planning board to prepare the Second Amendment to the Original Plan; and

**WHEREAS**, on May 5, 2010, the Municipal Council adopted Ordinance 6PSF-H approving the Second Amendment to the Original Plan as recommended by a resolution of the Central Planning Board dated March 15, 2010 (collectively, the “Second Amended Plan”); and

**WHEREAS**, the Municipal Council wishes to direct the Planning Board to prepare a Third Amendment to the Original Plan, in accordance with N. J. S.A. 40A: 12A-7f of the Local Redevelopment and Housing Law.

**NOW, THEREFORE BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY THAT:**

1. The Municipal Council directs the Central Planning Board to prepare a Third Amendment of the Newark Downtown Core District Redevelopment Plan and Amendment to the Newark Plaza Urban Renewal Plan and transmit the proposed plan to the Municipal Council for its consideration in accordance with N.J.S.A. 40A:12A-7f.
2. This Resolution shall take effect immediately.
