NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL, OF THE CITY OF NEWARK, NEW JERSEY, THAT:

1. The term of the Constable appointment of Darnell Jones II, is for a period of three (3) years from the date of appointment or the expiration of the Constable Bond, whichever

occurs first.

2. The Constable Bond, in the amount of \$1,000.00 issued to Darnell Jones II, o 106 Huntington Terrace, Newark, New Jersey 07112, is approved as to form, amount and sufficiency.

STATEMENT:

This resolution hereby authorizes and approves as to form, amount and sufficiency the Constable Bond for Darnell Jones II, 106 Huntington Terrace, Newark, New Jersey 07112, who was appointed to serve as Constable in the City of Newark, New Jersey, for a period of three (3) years.
