AN ORDINANCE AMENDING SECTION 23:5-14e, PARKING BY PERMIT ONLY IN DESIGNATED RESIDENTIAL AREAS, OF TITLE 23, TRAFFIC AND PARKING, OF THE REVISED GENERAL ORDINANCES OF THE CITY OF NEWARK, NEW JERSEY, 2000, AS AMENDED AND SUPPLEMENTED, BY ADDING NORTH 5TH STREET BETWEEN ROPES PLACE AND ANTHONY STREET TO THE EXISTING PERMIT PARKING AREAS DESIGNATED LIST.

WHEREAS, the residents of North 5th Street have submitted a petition for Permit Parking on North 5th Street between Ropes Place and Anthony Street, in the North Ward.

NOW, THEREFORE, BE IT ORDAINED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

Section 1. That Section 23:5-14e, Parking by Permit Only in Designated Residential Areas, of Title 23, Traffic and Parking, of the Revised General Ordinances of the City of Newark, New Jersey, 2000, be amended and supplemented by adding thereto the following:

North 5th Street, West side, between Ropes Place and Anthony Street
(Hours: 24 hours / Days: Monday-Sunday)

Section 2. Regulatory signs shall be erected and maintained by the City of Newark.

Section 3. Any ordinance or parts thereof inconsistent with this ordinance are hereby repealed.

Section 4. This ordinance shall take effect upon final passage and publication and in accordance with the laws of the State of New Jersey.

Section 5. This ordinance does not require approval by the Commissioner of the State of New Jersey Department of Transportation.

STATEMENT

This ordinance amends City of Newark Ordinances Title 23, Traffic and Parking, Section 23:5-14e, Parking By Permit Only In Designated Residential Areas, Of Title 23, Traffic And Parking, to allow Parking By Permit Only on North 5th Street between Ropes Place and Anthony Street, in the North Ward.
