NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

- 1. The following temporary appropriation be made and a certified copy of this resolution be transmitted to the Acting Chief Financial Officer for his/her records.
- 2. The Governing Body by two-thirds vote of its full membership hereby amends its temporary budget by making the following temporary appropriations:
