AN ORDINANCE AMENDING SECTION 23:5-14e, PARKING BY PERMIT ONLY IN DESIGNATED RESIDENTIAL AREAS, OF TITLE 23, TRAFFIC AND PARKING, OF THE REVISED GENERAL ORDINANCES OF THE CITY OF NEWARK, NEW JERSEY, 2000, AS AMENDED AND SUPPLEMENTED, BY ADDING ST. CHARLES STREET BETWEEN KOSSUTH STREET AND KOMORN STREET TO THE EXISTING PERMIT PARKING AREAS DESIGNATED LIST.

WHEREAS, the residents of St. Charles Street have submitted a petition for Permit Parking on west side of St. Charles Street between Kossuth Street and Komorn Street, in the East Ward.

NOW, THEREFORE, BE IT ORDAINED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

Section 1. That Section 23:5-14e, Parking by Permit Only in Designated Residential Areas, of Title 23, Traffic and Parking, of the Revised General Ordinances of the City of Newark, New Jersey, 2000, be amended and supplemented by adding thereto the following:

St. Charles Street, West side, between Kossuth Street and Komorn Street
(Hours: 24 hours / Days: Monday-Sunday)

Section 2. Regulatory signs shall be erected and maintained by the City of Newark.

Section 3. Any ordinance or parts thereof inconsistent with this ordinance are hereby repealed.

Section 4. This ordinance shall take effect upon final passage and publication and in accordance with

the laws of the State of New Jersey.

Section 5. This ordinance does not require approval by the Commissioner of Transportation.

STATEMENT:

This ordinance allows Parking by Permit Only on the west side of St. Charles Street, between Kossuth Street and Komorn Street, in the East Ward.
