AN ORDINANCE AMENDING SECTION 23:5-14e, PARKING BY PERMIT ONLY IN DESIGNATED RESIDENTIAL AREAS, OF TITLE 23, TRAFFIC AND PARKING, OF THE REVISED GENERAL ORDINANCES OF THE CITY OF NEWARK, NEW JERSEY, 2000, AS AMENDED AND SUPPLEMENTED, BY ADDING 2^{ND} STREET BETWEEN ORANGE STREET AND 7^{TH} AVENUE TO THE EXISTING PERMIT PARKING AREAS DESIGNATED LIST.

WHEREAS, the residents of 2nd Street have submitted a petition for Permit Parking on 2nd Street between Orange Street and 7th Avenue.

NOW, THEREFORE, BE IT ORDAINED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

Section 1. That Section 23:5-14e, Parking by Permit Only in Designated Residential Areas, of Title 23, Traffic and Parking, of the Revised General Ordinances of the City of Newark, New Jersey, 2000, be amended and supplemented by adding thereto the following:

2nd Street, both sides between Orange Street and 7th Avenue.

(Hours: 24hrs. / Days: Monday-Sunday)

Section 2. Regulatory signs shall be erected and maintained by the City of Newark.

Section 3. Any ordinance or parts thereof inconsistent with this ordinance are hereby repealed.

Section 4. This ordinance shall take effect upon final passage and publication and in accordance with the laws of the State of New Jersey.

Section 5. This ordinance does not require approval by the Commissioner of Transportation.
