item shall have been made available by law and the amount thereof shall not have been determined at the time of the adoption of the budget, and may approve the insertion of any appropriation item of equal amount for the purpose of carrying out the purposes the law making such item of revenue available for expenditure; and

**WHEREAS,** the North Jersey Transportation Planning Authority (NJTPA), has made available \$280,000.00 for the Newark Downtown Circulation Improvement Study; and

**WHEREAS**, by award letter dated July 1, 2015, from the North Jersey Transportation Planning Authority (NJTPA), the City of Newark was awarded \$280,000.00 (Federal Funding) for Newark Downtown Circulation Improvement Study, with a Local In-Kind Match of \$70,000.00, for a total Grant of \$350,000.00.

# NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

- 1. In accordance with the provisions of N.J.S.A 40A:4-87, the City of Newark hereby requests the Director of Local Government Services to approve a budget insertion in the amount of \$280,000.00 (Federal Funding) with a Local In-Kind Match of \$70,000.00, for a total grant of \$350,000.00, an appropriation of equal amount for the Newark Downtown Circulation Improvement Study in the budget year 2015 as set forth in Schedule A, attached hereto and made a part hereof.
- 2. The aforesaid insertion is in the opinion of the Governing Body, warranted and authorized by N.J.S.A. 40A:4-87 and are necessary for the orderly operation of the municipality.
- 3. A copy of this resolution shall be immediately filed with the Director of Local Government Services by the City Clerk of the City of Newark.
