- 1. Ronnie Eugene Kellam, of 134 North 13th Street, 1st Floor, Newark, New Jersey 07107, be and is hereby appointed as a Constable, in accordance with his application to serve civil and criminal warrants, summonses, complaints, repossessions, lockouts and writs.
- 2. Prior to carrying out the duties of his office and no later than thirty (30) days after the effective date of the appointment, the aforesaid appointee shall submit a Constable Bond, which shall be approved as to form, amount and sufficiency of Surety by resolution of the Newark Municipal Council.
- 3. This appointment shall be for a term of three (3) years from the date of appointment or the expiration of the Constable Bond, whichever occurs first.
