**WHEREAS,** on April 16, 2016, an earthquake of large proportions devastated several areas of Ecuador; and

**WHEREAS,** it might be too dangerous for a safe return home for many Ecuadorians residing in the United States; and

**WHEREAS,** Temporary Protected Status (T.P.S.) is an immigration benefit granted to nationals of foreign countries that have experienced a disaster or conflict that makes it too dangerous for a safe return home; and

**WHEREAS,** Temporary Protected Status allows Ecuadorians to help support the recovery effort through their remittances and T.P.S. delays deportations until the country is stable enough to accept returning nationals.
