**WHEREAS**, the purchase of goods/services by Local contracting units is authorized by Local Public Contracts Law, N.J.S.A. 40A: 11-12; and

**WHEREAS**, in accordance with N.J.S.A. 40A:11-11(5), N.J.S.A. 52:25-16.1, et. seq. and N.J.A.C. 5:34-7.1, all Cooperative Purchasing Program participants are responsible for ensuring that the Purchase Order issued reflects the correct contract item pricing and that payment is processed accordingly. Only the items/services specified in the applicable State contract(s) may be purchased from the contract vendor(s) of record. Cooperative Purchasing participants assume full responsibility for all purchase transactions issued through State contracts, including Purchase Orders, delivery compliance, and payments; and

**WHEREAS**, the City wishes to utilize the term Contract, #T-2276 Influenza Vaccine-Statewide, State Contract with the following vendor commencing upon adoption of this resolution through December 31, 2020:

**WHEREAS,** the Supervising Procurement Specialist, recommends the utilization of this State contract award on the grounds that it provides Flu Vaccine for Adults and is also appropriate for children 6 months of age, as required by the City of Newark, Department of Health and Community Wellness; and

**WHEREAS**, usage of this contract provides the Flu Vaccine for Adults and is appropriate for children 6 months of age, at a cost not to exceed \$85,000.00; and

WHEREAS, the Chief Financial Officer will certify the availability of funds before orders are placed.

## NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

- 1. Pursuant to N.J.S.A. 40A:11-1 et seq., and N.J.A.C. 5:34-7.29, the Supervising Procurement Specialist is authorized to utilize Contract, term # T-2276, Influenza Vaccine Statewide which includes the following vendor: #41502, FFF Enterprises to purchase Flu Vaccine for Adults and is appropriate for children 6 months of age for the City of Newark, for the period commencing from the adoption of this resolution through December 31, 2020.
- 2. All purchases, purchase orders and other related documentation shall be in accordance with the relevant State Contract, State of New Jersey Standard Terms and Conditions, Method of Operation and Third Party Agreement/Three Party Agreement (if applicable) as contained in the State Contract documentations and agreements.
- 3. There shall be no amendment of this resolution without the approval of the Municipal Council.
- 4. There shall be no advance payment on this State contract in accordance with N.J.S.A. 40A: 5 -16. Funding is contingent upon appropriation pursuant to N.J.A.C. 5:30-5.5(c).
- 5. This contract is awarded as an open-ended contract; pursuant to N.J.A.C. 5:30-5.5(d) (2). A certification of the Availability of Funds shall be executed each time a purchase order is placed and charged against this contract. This contract shall not exceed \$85,000.00
