# NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

1. Pursuant to N.J.S.A. 40A:11-1 *et seq.*, and N.J.A.C. 5:34-7.29, the Supervising Procurement Specialist is authorized to utilize term contract # T-2007, "Vehicles, Sport Utility (SUV)", to provide One (1) Sport Utility Vehicle (SUV), to the City of Newark, for the period commencing from the adoption of this resolution to complete delivery, not to exceed October 29, 2016 and or inclusive of any contract extensions approved by State Contract, which includes the following vendor.

#83013, Beyer Ford LLC, 170 Ridgedale Avenue, Morristown, New Jersey 07962

2. All purchases, purchase orders and other related documentation shall be in accordance with the relevant State Contract, State of New Jersey Standard Terms and Conditions, Method of Operation and Third Party Agreement/Three Party Agreement (if applicable) as contained in the State Contract Documentations and Agreements.

3. There shall be no amendment of this resolution without the approval of the Municipal Council.

4. There shall be no advance payment on this State contract in accordance with N.J.S.A. 40A: 5 -16. Funding is contingent upon appropriation; pursuant to N.J.A.C. 5:30-5.5(c).

5. Funds for the purchase of this vehicle are encumbered on PO# NW011 116516, 011-110-1110-94430-B2016 for \$28,778.00. This contract shall not exceed \$28,778.00.
