WHEREAS, the City of Newark, Department of Engineering, Division of Traffic and Signals, , advertised for receipt of bids on March 23, 2016, for Contract No. 02-2016, Installation of Pavement Markings on Various Streets in the City of Newark; and

WHEREAS, on April 28, 2016, four (4) bids were received for Contract No. 02-2016, Installation of Pavement Markings on Various Streets in the City of Newark, in accordance with the Local Public Contracts Law, N.J.S.A. 40A:11-1, et seq.; and

WHEREAS, based on a review of the bids, the Director of the Department of Engineering, rejects the bid proposal submitted by the lowest bidder Dan Swayze & Son, Inc., 2351 Waldheim Avenue, Scotch Plains, New Jersey 07076, because they did not meet the minimum of 25% required for Minority Business Enterprises and 7% Women Business Enterprises; and

WHEREAS, the Director of the Department of Engineering, desires to accept the bid proposal submitted by the lowest responsible bidder, Statewide Striping Corporation, 499 Pomeroy Road, Parsippany, New Jersey 07054 and execute Contract No. 02-2016, Installation of Pavement Markings on Various Streets in the City of Newark, for the total bid amount of \$150,225.00.

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

1. The Mayor and/or his designees, the Director of the Department of Engineering, are hereby authorized on behalf of the City of Newark, to accept the bid proposal submitted by the lowest responsible bidder, Statewide Striping Corporation, 499 Pomeroy Road., Parsippany, New Jersey 07054 and execute Contract No. 02-2016, Installation of Pavement Markings on Various Streets in the City of Newark,, for the total bid amount of \$150,225.00.
2. Attached hereto is a Certification of Funds from the Director of Finance of the City of Newark which states, (1) that there are available sufficient legally appropriated funds in the amount of \$150,225.00 for the purpose set forth hereinabove, and (2) that the line appropriation of the official budget which shall be charged is as follows:
