**WHEREAS,** an emergency has arisen in Special Item of Appropriation in the amount of \$59,520.00 bringing total program resources to \$4,111,826.00, for the continued provision of Homeless HRSA Program and no adequate provision has been made in the 2017 Temporary Budget for the aforesaid purpose and N.J.S.A. 40A: 4-20 provides for the creation of an emergency appropriation for the purpose above-mentioned; and

**WHEREAS,** by authorizing Resolution 7R2-b dated March 2, 2016, from the United States Department of Health and Human Services/Health Resources and Services Administration (HRSA), the City of Newark has accepted \$59,520.00 to continue providing medical care, social services, substance abuse and mental health counseling to the homeless population within the City of Newark; and

**WHEREAS,** N.J.S.A. 40A:4-20 provides that the Governing Body, by a two-thirds vote, may make temporary emergency appropriations for any purpose for which appropriations may lawfully be made for the period between the beginning of the current fiscal year and the date of the adoption of the budget for said year; and

# NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

1. A temporary emergency appropriation be, and the same is hereby, made for the following classification.
