WHEREAS, the City of Newark seeks to obtain funding from the NJDOT Municipal Aid Program to improve various roads that include drainage, ADA ramps, resurfacing, decorative crosswalks and pavement markings throughout the City of Newark; and

WHEREAS, the City of Newark desires to further the public interest by obtaining funding from the NJDOT Municipal Aid Program for the following Street Resurfacing - Various Streets - 2017 - Newark (15 locations, MA-17) within the City of Newark; and

WHEREAS, on February 3, 2017, on behalf of the City of Newark, the Director of the Department of Engineering submitted an application to NJDOT requesting grant funding in the amount of \$1,879,000.00 (One Million Eight Hundred Seventy-Nine Thousand Dollars and Zero Cents) from the NJDOT Municipal Aid Program to carry out the above Street Resurfacing - Various Streets - 2017 - Newark (15 locations, MA-17) within the City of Newark, with no City funds required; and

WHEREAS, pursuant to the terms of the grant application, a copy of which is attached hereto, the City of Newark is required to submit a resolution from the Newark Municipal Council authorizing submission of the grant application; and

WHEREAS, upon notification of the receipt of a grant award in connection with this application, the Director of the Department of Engineering, desires to accept the grant award and execute a grant agreement governing said award; and

WHEREAS, upon notification of the receipt of a grant award in connection with this application the Director of Department of Engineering shall submit a copy of the grant agreement to the City Clerk, Corporation Counsel and the Business Administrator for review, approval, and signature.

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

1. The Mayor and/or his designee, the Director of the Department of Engineering, are hereby authorized to submit an electronic grant application to the New Jersey Department of Transportation on behalf of the City of Newark, requesting grant funding in the amount of \$1,879,000.00 (One Million Eight Hundred Seventy-Nine Thousand Dollars and Zero Cents) from the NJDOT Municipal Aid Program for Street Resurfacing - 15 Various Streets - 2017 - Newark (15 locations, MA-17), with no City funds required (a copy of the application is attached hereto and made a part hereof).
2. The Municipal Council hereby ratifies its authorization of this application from the date of application submission to the date of adoption of this authorizing resolution.
3. Upon notification of the receipt of a grant award in connection with this application, the grant is hereby accepted in the amount applied for and/or any increase or decrease thereto.
4. Upon notification of the receipt of a grant award in connection with this application, the Mayor and/or his designee, the Director of the Department of Engineering, is hereby authorized to enter into and execute grant documents with the New Jersey Department of Transportation to receive and expend the grant award from the NJDOT Municipal Aid Program for the following Street Resurfacing - Various Streets - 2017 - Newark (15 locations, MA-17) within the City of Newark:
