WHEREAS, an emergency has arisen in Special Item of Appropriation in the amount of \$150,000.00 for Target Hardening of the Pequannock Water Treatment Plant and no adequate provision has been made in the 2017 Temporary Budget for the aforesaid purpose and N.J.S.A. 40A: 4-20 provides for the creation of an emergency appropriation for the purpose above-mentioned; and

WHEREAS, by Resolution 7R12-a dated December 7, 2016, the City of Newark accepted Target Hardening of the Pequannock Water Treatment Plant in the amount of \$150,000.00 for the Newark Water Interconnect at the Belleville Reservoir; and

WHEREAS, N.J.S.A. 40A: 4-20 provides that the Governing Body by a two-thirds vote may make temporary emergency appropriations for any purpose for which appropriations may lawfully be made for the period between the beginning of the current fiscal year and the date of the adoption of the budget for said year; and

WHEREAS, emergency appropriation adopted in 2017, pursuant to N.J.S.A. 40A: 4-20 including this resolution total.....\$150,000.00.

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE CITY OF NEWARK, NEW JERSEY, THAT:

1. A temporary emergency appropriation be and the same is hereby made for the following classification.

2. Said emergency appropriation shall be provided for in the 2017 budget.
3. A copy of this resolution shall be immediately filed with the Director of Local Government Services by the City Clerk of the City of Newark.

STATEMENT

This resolution establishes a temporary emergency appropriation and revenue for the 2017 Municipal Budget in the amount of \$150,000.00 for the Target Hardening of the Pequannock Water Treatment Plant. The Office of Homeland Security and Preparedness, State of New Jersey, is providing the funds. The project period is September 1, 2016 through August 31, 2019 (City-wide).
